This Amendment No. 1 ("Amendment No. 1") amends and supplements the statement on Schedule 13D filed with the Securities and Exchange Commission (the "SEC") on April 27, 2016 (the "Original Schedule 13D"). And together with the Original Schedule 13D, this Amendment No. 1 with respect to the shares of common stock, \$0.001 per share (the "Shares"), of Advent Claymore Convertible Securities and Income Fund II (the "Issuer"). This Amendment No. 1 amends Items 3 and 5 as set forth below.

Item Source and amount of funds or other consideration**3.**

Item 3 of the Schedule 13D is hereby amended and restated as follows:

Funds for the purchase of the Shares were derived from the subscription proceeds from investors in SCMF, SCMF II, SCLMF, SCS, SCEF 1 and SCEF 2 and the capital appreciation thereon and margin account borrowings made in the ordinary course of business. In such instances, the positions held in the margin accounts are pledged as collateral security for the repayment of debit balances in the account, which may exist from time to time. Since other securities are held in the margin accounts, it is not possible to determine the amounts, if any, of margin used to purchase the Shares reported herein. A total of \$21,579,315 was paid to acquire the Shares reported herein

Item Interest in Securities of the Issuer**5.**

Item 5 of the Schedule 13D is hereby amended and restated as follows:

- (a) See rows (11) and (13) of the cover pages to this Schedule 13D for the aggregate number of Shares and percentages of the Shares beneficially owned by each of the Reporting Persons.
