Information with respect to each of OIML and OAML (collectively, the "Reporting Persons") is given solely by each such Reporting Person and no Reporting Person has responsibility for the accuracy or completeness of information supplied by the other Reporting Person. OIML is the beneficial owner of 2,645,230 shares of class A common stock or 8.7% of the 30,416,440 shares of class A common stock of Copa Holdings, S.A. believed to be outstanding. OAML is the beneficial owner of 20,570 shares of class A common stock or 0.1% of the 30,416,440 shares of class A common stock of Copa Holdings, S.A. believed to be outstanding.
