- (1) Based on the Company's EBT performance in 2013, 139.5% of the original award of 2,228 performance-based restricted stock units granted 2/21/13 were earned, resulting in an additional 880 units, for a total of 3,108 units. The restrictions will lapse with respect to 1,025 units on 2/23/15 and with respect to 1,058 units on 2/21/16, subject to continued employment by the Reporting Person on the remaining vesting dates.
