(1) Options to Purchase Issuer's Class A common stock, \$.001 par value

(2) An option to purchase 20,000 shares of the Issuer's common stock, par value \$.001 per share, was issued to the Reporting person under the Issuer's 1998 Stock Option Plan. One-fifth of such option became exercisable on each of October 19, 2000, October 19, 2001, October 19, 2002, October 19, 2003 and October 19, 2004.

(3) An option to purchase 20,000 shares of the Issuer's common stock, par value \$.001 per share, was issued to the Reporting person under the Issuer's 1998 Stock Option Plan. One-fifth of such option became exercisable on each of November 9, 2001, November 9, 2002, and November 9, 2003. The balance of such option becomes exercisable in one-fifth on each of November 9, 2004 and November 9, 2005.

(4) Class A common stock, \$.001 par value
