#### Item 8.01 Other Events.

On January 10, 2007, the parties to the Agreement and Plan of Merger (the <u>Merger Agreement</u>), dated December 19, 2006, among Harrah s Entertainment, Inc., a Delaware corporation (the <u>Company</u>), Hamlet Holdings LLC, a Delaware limited liability company (<u>Parent</u>), and Hamlet Merger Inc., a Delaware corporation and a wholly-owned subsidiary of Parent (<u>Merger Sub</u>), agreed to a waiver (the <u>Waiver</u>) to the Merger Agreement. The Waiver provides that the Company, Parent and Merger Sub shall not be obligated to make their pre-merger notification filings under the Hart-Scott-Rodino Antitrust Improvements Act of 1976 by the 15th business day following the execution of the Merger Agreement, but instead shall make such filings no later than February 28, 2007.

The foregoing summary of the Waiver does not purport to be complete and is subject to, and qualified in its entirety by, the full text of the Waiver, which is attached as Exhibit 99.1 and incorporated herein by reference.
