**Qualified holding and long position**    **Morgan Stanley**

Portugal Telecom, SGPS S.A. ( PT ) hereby informs that it was notified of the following regarding a qualified holding and long position of Morgan Stanley:

**A) 2% threshold exceeded (28 February 2014)**

This change is due to Morgan Stanley & Co. International plc and Morgan Stanley & Co. LLC increasing borrowed positions by 7,139,878 and 1,000,000 PT ordinary shares, respectively, on 28 February 2013. As a result, Morgan Stanley held a qualified holding and long position corresponding to 2.28% of PT 's share capital and corresponding voting rights. Additionally, PT was informed that this holding is as follows:

**Holdings in PT ordinary shares:**

- Morgan Stanley & Co. International plc: 13,723,234 ordinary shares representing 1.53% of the share capital and voting rights in PT;
- Morgan Stanley & Co. LLC: 6,575,294 ordinary shares representing 0.73% of the share capital and voting rights in PT;
- Morgan Stanley Smith Barney LLC: 83,711 ordinary shares representing 0.01% of the share capital and voting rights in PT.

**Holdings in financial instruments:**

- Morgan Stanley & Co. International plc: 39,282 ordinary shares via financial instruments, representing 0.004% of the share capital and voting rights in PT.

**B) Position fell below 2% threshold (3 March 2014)**

This change is due to Morgan Stanley & Co. International plc decreasing borrowed positions by 2,676,410 PT shares and decreasing a share position by 489,736 PT ordinary shares, on 3 March 2014. As a result, Morgan Stanley now holds a position corresponding to 1.92% of PT's share capital and corresponding voting rights. Additionally, PT was informed that this position is as follows:
