**Item 8.01 Other Events.**

On June 24, 2014, PetroLogistics LP (the Company ) issued a press release announcing that the Company and PetroLogistics Finance Corp. ( Finance Corp. and together with the Company, the Issuers ) are soliciting consents (the Consent Solicitation ) from holders of the Issuers outstanding 6.25% Senior Notes due 2020 (the Notes ) to approve amendments to the Indenture relating to the Notes. The Issuers are making the Consent Solicitation at the request and expense of Flint Hills Resources, LLC ( Flint Hills ), a subsidiary of Koch Industries, Inc. On May 27, 2014, the Company and its general partner entered into a definitive agreement to be acquired by Flint Hills (the Merger ).

A copy of the press release is furnished as Exhibit 99.1 hereto. The furnishing of the press release as an exhibit to this report does not constitute a solicitation of consents or proxies or an offer to sell or a solicitation of an offer to buy any security in connection with the Merger or otherwise.
