WP is the managing member of Warburg Pincus Partners GP LLC, which is the general partner of Warburg Pincus Partners, L.P., which is the managing member of WPP GP LLC. WP LLC is the manager of the WP VIII Funds, the WP X Funds, and WP X O&G. Each of the WP VIII Funds, the WP X Funds, WP X O&G, WP X GP, WP X GP LP, WP-WPVIII GP LP, WP Antero, WP Partners, WP LLC and WP are collectively referred to herein as the "Warburg Pincus Entities."
