(b) On July 11, 2016, Stormy D. Simon, President of Overstock.com, Inc. (the Company ) and a member of the Board of Directors, advised the Company that she would be resigning as President of the Company effective no later than July 25, 2016, and that she would resign her position as a member of the Board of Directors no later than September 30, 2016.

(e) In connection with Ms. Simon's resignation, the Company and Ms. Simon have entered into a mutual release and the Company has agreed (i) to pay her a severance payment of \$325,000, and (ii) to vest a total of 19,759 shares of unvested Restricted Stock Units previously granted to Ms. Simon.
