Reporting person deferred previous bonuses. The company match vests ratably at 33%, 33% and 34% per year over a 3 year period. Special common share units vested at 12/31/10 were 66,098.81. This bonus was approved on March 4, 2011, and we have calculated the deferral using the March 4 stock price. Cash bonuses will be paid on March 11, 2011.
