- (1) Represents an award of restricted share units granted on February 11, 2009.

- (4) The options vest in three equal annual installments beginning on the first anniversary of the date of grant.

If stockholders fail to approve the plan amendments at the 2009 annual meeting of stockholders, the term of the options reported on herein will revert to seven years (so that the expiration date will be 2/11/2016) in accordance with the terms of the plan prior to amendment.
