- (1) Mr. Robertson has transferred substantially all of his interests in New Gauley Coal Corporation to various trusts for the benefit of his grandchildren. Because the terms of the trusts dictate that Mr. Robertson no longer has voting or investment power over the shares of New Gauley transferred to the trusts, he no longer controls New Gauley Coal Corporation, and thus does not claim the NRP common units held by New Gauley. New Gauley continues to own the 670,024 common units.

- (2) These units continue to be owned by New Gauley Coal Corporation, a corporation previously controlled by Mr. Robertson prior to the transfers indicated in Footnote 1.

- These units are beneficially owned by Western Pocahontas Properties Limited Partnership, whose general partner is Western Pocahontas Corporation, a corporation controlled by Mr. Robertson. Mr. Robertson also holds indirect limited partner interests in Western Pocahontas Properties Limited Partnership. All the common units owned by Western Pocahontas Properties Limited Partnership are reported on this line. Mr. Robertson disclaims beneficial ownership of the reported securities except to the extent of his pecuniary interest therein.

- (4) These units are beneficially owned by Western Bridgeport, Inc., a corporation controlled by Mr. Robertson. Mr. Robertson disclaims beneficial ownership of the units held by Western Bridgeport, Inc., except to the extent of his pecuniary interest therein.
