(1) Mr. Kennedy did not sell any of the 10,438 reported shares. Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of withholding taxes due upon the 1/10/12 vesting of 28,084 of the 84,250 shares of restricted stock Mr. Kennedy was granted on 12/8/08. These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.

(2) Of these 111,550 shares reflected as beneficially owned, 20,000 shares are shares held in the reporting person's account under the Revlon Employees' Savings, Investment and Profit Sharing Plan.
