Following a registered underwritten secondary offering of Class A common stock, par value \$0.01 per share, of INC Research Holdings, Inc., OTPP converted 6,866,555 shares of Class B common stock, par value \$0.01 per share into an equal number of shares of Class A common stock, par value \$0.01 per share.
