(“MYJ”), with MYJ continuing as the surviving fund after the reorganizations. Holders of the VRDP Shares of BNJ and BLJ will receive on a one-for-one basis MYJ VRDP Shares in an amount equal to the aggregate VRDP Share liquidation preference (including any accumulated and unpaid dividends) held by such holders of VRDP Shares immediately prior to the reorganizations.
