As of November 8, 2013, Whippoorwill may be deemed to be the beneficial owner of an aggregate of 571,053 Common Shares, representing 5.0% of the Common Shares. The above number of Common Shares consists of the 571,053 Common Shares currently issuable upon the conversion of the \$18,055,414 of Series A Notes and the \$642,057 of 10% Series B Convertible Senior Secured Notes due 2015 (the "Series B Notes"), respectively, reflected on an as-converted basis. The above number of Common Shares issuable upon conversion of the Series B Notes includes the Common Shares issuable as a "make-whole" premium, which is equal to the sum of undiscounted interest that would have been paid in kind on the principal amount of the Series B Notes converted from the last date interest was paid immediately prior to such conversion through and including the maturity of the note as though such Series B Notes had remained outstanding until maturity.

The Common Shares disclosed herein as beneficially owned by Whippoorwill are held for the account of various funds and third party accounts for which Whippoorwill has discretionary authority and acts as general partner or investment manager.

As of November 8, 2013, Messrs. Greenhaus and Gendal may each be deemed the beneficial owner of 571,053 Common Shares deemed to be beneficially owned by Whippoorwill, as described above. Mr. Greenhaus is the President and a Principal of Whippoorwill. Mr. Gendal is a Principal of Whippoorwill.
