- (1) The reported amount of restricted stock units (RSUs) and stock appreciation rights (SARs), collectively, represents the 75% portion of a target equity award that is subject to time vesting in three approximately equal annual installments beginning one year from the grant date. The remaining 25% of the target equity award may vest on August 13, 2015, if the registrant achieves certain pre-determined financial performance targets, subject to certification by the registrant's Compensation Committee on March 1, 2015.
