- (1) The phantom stock units convert to shares of common stock on a 1-for-1 basis.

- (3) The phantom stock units will be paid in cash or shares of Aon common stock on a distribution date elected by the reporting person.
- (4) The deferred stock units convert to shares of common stock on a 1-for-1 basis.
- (5) The deferred stock units represent an outside director stock award granted annually to each non-employee director of Aon Corporation. The deferred stock units vest over a one-year period, and will convert to and be paid in shares of Aon common stock upon the earlier of:
 - (6) (a) the third anniversary of the date of grant; or (b) the director's termination of service from the Board, in each case unless a timely deferral election is made.
- (7) Includes shares acquired pursuant to dividend reinvestment.
