- (1) On March 31, 2005, the common stock for Cabot Oil & Gas Corporation split 3-for-2, resulting in the reporting person's acquisition 73,458 additional shares of common stock.
- (2) This option was previously reported as covering 5,000 shares at an exercise price of \$19.375, but was adjusted to reflect the stock split on March 31, 2005.
- (3) On March 31, 2005, the common stock for Cabot Oil & Gas Corporation split 3-for-2, resulting in the reporting person's acquisition of an option on 11,750 additional shares of common stock.
