- (1) Grant of non-qualified stock option pursuant to 2006 Omnibus Stock Incentive Plan.

Upon notice of redemption, Common Units are redeemable for cash based on the fair market value of an equivalent number of shares of the Issuer's common stock, or, at the election of the Issuer, for an equal number of shares the Issuer's common stock.
