 - (1) Acquired pursuant to the First Amended and Restated Agreement and Plan of Merger, dated as of September 3, 2010 (the "Merger Agreement"), by and among Inergy, L.P. ("Inergy"), Inergy GP, LLC, Inergy Holdings, L.P. ("Holdings"), Inergy Holdings GP, LLC, NRG Limited Partner, LLC and NRG MS, LLC. Acquired 4,897 common units representing limited partner interests in Inergy on November 5, 2010 pursuant to the Merger Agreement in exchange for 6,360 Holdings common units. On the effective date of the merger, the closing sales price of Holdings common units on the NYSE was \$30.71, and the closing sales price of Inergy common units on the NYSE was \$39.95 per unit.
 - (2) Acquired pursuant to Merger Agreement in exchange for options to purchase 60,000 Holdings common units at \$11.50 per unit.
 - (3) Includes Inergy restricted units acquired pursuant to the Merger Agreement.
