(1) Mr. Boisseau, a member of the Issuer's board of directors, is a member of the Executive Committee of Total S.A., the ultimate parent company of Total Gas & Power USA, SAS, and, as such, may be deemed to share voting or investment power over the securities held by Total Gas & Power USA, SAS. Mr. Boisseau holds no shares of the Issuer directly and disclaims beneficial ownership of the Common Stock, except to the extent of his pecuniary interest therein, if any.

(2) On December 24, 2012, \$4,999,998.96 of the \$38,300,000 Note was converted into 1,677,852 shares of Common Stock at a conversion price of \$2.98 pursuant to a Securities Purchase Agreement among the Issuer, the Reporting Person and other investors of the Issuer. The remaining principal amount of the Note is \$33,300,001.04. The Note is convertible only in those circumstances described in the Note. The Final Maturity Date as defined in the Note is March 1, 2017.
