- (1) Represents 5% quarterly vesting on June 1, 2014. Original grant was 1400 RSUs, with 20% vested on March 1, 2011, and the remaining 80% vesting in equal quarterly installments over the remaining four years.
- (2) Each restricted stock unit represents the right to receive, following vesting, one share of Pegasystems Inc.'s common stock.
- (3) Once vested, the shares of common stock are not subject to expiration.
- (4) This grant of Restricted Stock Units was previously reported as 700 shares, but has been adjusted to reflect the 2-for-1 stock split that occurred on April 1, 2014.
