- (1) On September 7, 2012, the Reporting Person received a grant of restricted stock units ("RSUs") covering 3,140 shares of KLA-Tencor common stock. On September 7, 2014, the Reporting Person vested in twenty-five percent (25%) of such RSUs.
- (2) Pursuant to the terms of the September 7, 2012 RSU grant, 296 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. Because the vesting date of such RSUs occurred on a day on which the NASDAQ Stock Market was closed for trading, the fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares

to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on the last completed trading day immediately prior to such vesting date.

- (3) On September 7, 2012, the Reporting Person received a supplemental grant of RSUs covering 3,140 shares of KLA-Tencor common stock. On September 7, 2014, the Reporting Person vested in fifty percent (50%) of such RSUs.

Pursuant to the terms of the September 7, 2012 supplemental RSU grant, 591 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. Because the vesting date of such RSUs occurred on a day on which the NASDAQ

- (4) Stock Market was closed for trading, the fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on the last completed trading day immediately prior to such vesting date.
- (5) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
- Does not include performance-based RSUs, if any, held by the Reporting Person for which an assessment has not yet been made
