Manning & Napier Advisors, Inc. ("MNA"), an investment adviser governed under the U.S. Securities and Exchange Commission ("SEC"), has conducted a corporate reorganization (effective October 1, 2011) that resulted in a newly formed Delaware limited liability company, called Manning & Napier Advisors, LLC. Manning & Napier Advisors, LLC, also a registered investment adviser, will assume the same roles and responsibilities as MNA including governance under the SEC.

Previously, we have submitted all disclosure filings on behalf of MNA when the voting authority granted to MNA by its affiliates and underlying clients creates an obligation to file a notification in your jurisdiction. As of October 1, 2011, we will continue to satisfy such obligations; however, all disclosures will be filed on behalf of the new entity Manning & Napier Advisors, LLC.

^[i] This form is to be sent to the issuer or underlying issuer and to be filed with the competent authority.

^[ii] Either the full name of the legal entity or another method for identifying the issuer or underlying issuer, provided it is reliable and accurate.

^[iii] This should be the full name of (a) the shareholder; (b) the natural person or legal entity acquiring, disposing of or exercising voting rights in the cases provided for in Article 10 (b) to (h) of Directive 2004/109/EC; (c) all the parties to the agreement referred to in Article 10 (a) of that Directive, or (d) the holder of financial instruments entitled to acquire shares already issued to which voting rights are attached, as appropriate.
