This Registration Statement on Form S-1 is being filed with respect to the registration of additional shares of common stock, par value \$0.001 per share, of NightHawk Radiology Holdings, Inc., a Delaware corporation, pursuant to Rule 462(b) under the Securities Act of 1933, as amended. This Registration Statement includes the registration statement facing page, this page, the signature pages, an exhibit index, an opinion of counsel regarding the legality of the securities being registered and a related consent and accountants' consents. This Registration Statement relates to the Registrant's Registration Statement on Form S-1, as amended (Registration No. 333-137853), initially filed by the Registrant on October 6, 2006 and declared effective by the Securities and Exchange Commission on October 25, 2006. The Registrant is filing this Registration Statement for the sole purpose of increasing the aggregate number of shares of common stock offered by certain selling stockholders by 500,000 shares and increasing by 75,000 the shares subject to purchase upon exercise of the underwriters' option to purchase additional shares of common stock from certain selling stockholders.
