On April 25, 2007, Inergy, L.P. (the Partnership ) issued a press release announcing an increase in the Partnership 's quarterly cash distribution to \$0.575 per limited partner unit (\$2.30 annually) for the quarter ended March 31, 2007. The Partnership also announced that as a result of the commercial operation of the Phase II expansion of the Stagecoach natural gas storage facility ( Stagecoach ), the special units that were issued in August 2005 to Inergy Holdings, L.P. in connection with the acquisition of Stagecoach, converted into 919,349 common units.
