(the Issuer) by the Reporting Persons in open market transactions in April 2009, the conversion into Class B Ordinary Shares of 46,191 Class A Ordinary Shares held by Daniel Dong Yang in June 2009, and the sale to the Issuer of 1,203,812 Class A Ordinary Shares and 11,296,188 Class B Ordinary Shares of the Issuer by SB Asia Investment Fund II, L.P. (SAIF) under a repurchase agreement dated June 1, 2009 (which sale was closed on June 12, 2009). Except to the extent supplemented by the information contained in this Amendment No. 3, the Statement, as amended as provided herein, remains in full force and effect.

Pursuant to Section 13(d) of the Exchange Act, and the rules promulgated thereunder, SB Asia Investment Fund II L.P., SAIF II GP L.P., SAIF Partners II L.P. and SAIF II GP Capital Ltd. may be deemed to beneficially own all of the shares held by Daniel Dong Yang in the Issuer. Mr. Yang disclaims beneficial ownership with respect to the above shares except to the extent of his pecuniary interest therein.
