Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On June 7, 2012, the Board of Directors ( Board ) of National Fuel Gas Company (the Company ) elected David C. Carroll to serve as a director of the Company, to hold office until the Company s next Annual Meeting of Stockholders. Mr. Carroll is President and Chief Executive Officer of the Gas Technology Institute, a tax-exempt, leading natural gas research, development and training organization. Mr. Carroll has been named to the Board s Nominating/Corporate Governance Committee.

The Company will compensate Mr. Carroll in the same manner it compensates its other non-employee directors, as described at page 13 of the Company s proxy statement filed January 20, 2012. In addition, like the Company s other directors, Mr. Carroll will receive an indemnification agreement, the terms of which are described in the Company s Form 8-K filed September 18, 2006.
