#### DEREGISTRATION OF COMMON STOCK

This Post-Effective Amendment No. 1 to the Registration Statement on Form S-8, which was originally filed on October 25, 1994 (file no. 033-56147) (the Registration Statement ) to register a total of 10,000,000 shares, with par value of \$0.10 per share, of the common stock (the Shares ) of Charming Shoppes, Inc. (the Company ), pursuant to the Company s 1993 Employees Stock Incentive Plan (the Plan ), is being filed to deregister all of the Shares not yet issued in connection with the Plan.

The Company has entered into an Agreement and Plan of Merger, dated as of May 1, 2012, by and among Ascena Retail Group, Inc., a

Delaware corporation (Ascena), Colombia Acquisition Corp., a Pennsylvania corporation and direct wholly owned subsidiary of Ascena (the Purchaser), and the Company, pursuant to which the Purchaser merged with and into the Company (the Merger) with the Company surviving the Merger as a direct wholly owned subsidiary of Ascena. Accordingly, pursuant to the undertaking contained in the Registration Statement to remove from registration by means of a post-effective amendment any of the securities that remain unsold at the termination of the offering, the Company hereby amends the Registration Statement by deregistering all Shares that were registered but unsold under the Registration Statement.
