## **Directions to the Spartan Stores, Inc. 2013 Annual Meeting**

### **From North of Grand Rapids**

Take US-131 to exit 85A for Market Avenue; travel northeast on Market Avenue toward downtown, Market Avenue becomes Monroe Avenue at Fulton Street. The Courtyard by Marriott hotel is past Fulton on the left.

### **From South of Grand Rapids**

Take US-131 to exit 85B for Pearl Street. Turn right on Pearl and travel east toward downtown. Turn right on Monroe; the hotel will be on your right.

### **From East or West of Grand Rapids**

Take I-196 to exit 77C for Ottawa Avenue/Downtown. Follow Ottawa Avenue south to Pearl Street. Turn right on Pearl, then left on Monroe Avenue. The hotel will be on the right.
