Subject: Important Update Regarding Covidien Acquisition

Dear Colleagues:

Today, we announced that we will proceed with the Covidien acquisition under a new financing approach. You can read our public statement [here](#).

This update does not affect the terms and conditions of the definitive agreement reached between the two companies in June, nor does it impact the important integration planning efforts we have underway. We intend to move forward and continue to work toward a closing of the transaction in late calendar year 2014 or early calendar year 2015.

Recently, the U.S. Treasury issued proposed guidelines that, if implemented, would impact our previously planned financing approach for the transaction. After reviewing our options, we came to the conclusion that the best structure for the completion of the deal is to use approximately \$16 billion in debt to finance the cash portion of the proposed transaction, rather than using cash from our foreign subsidiaries as previously planned.

It is important to remember that this proposed acquisition was conceived and undertaken for strategic reasons and is intended to create a company that can treat more patients, in more ways and in more places around the world. This has not changed. We continue to firmly believe this acquisition and structure are in the best interests of our shareholders, employees, patients and customers. And finally, we believe our combination will be uniquely positioned to help advance the goals of the Affordable Care Act in the U.S. as well as the objectives of virtually all health systems to drive access to high-quality, affordable health care for patients around the world.

Since the announcement of this transaction, our people have worked closely with our Covidien colleagues to plan for the integration of these two leading companies. I am extremely pleased with your work on this integration thus far,

which has served to reaffirm to me how compelling this combination will be in benefiting patients, physicians and health care systems around the world.

We still have a very busy few months ahead as we continue our integration planning. At this time, it is important that we continue to meet our current obligations and objectives in the marketplace, and I thank you in advance for maintaining your focus. Meeting our objectives through this process will only make the combined company stronger.

I will continue to keep you updated on the progress of the transaction and look forward to working with you to pursue the many opportunities ahead of us.
