**Item 5.07. Submission of Matters to a Vote of Security Holders**

(a) Digimarc Corporation (the Company ) held its Annual Meeting of Shareholders on April 29, 2016 (the Annual Meeting ).

(b) At the Annual Meeting, 7,001,031 shares were represented to vote either in person or by proxy, or 77% of the outstanding shares, which represented a quorum. The final results of voting for each matter submitted to a vote of shareholders at the Annual Meeting are as follows:

**Proposal 1: Election of Directors**

Bruce Davis, Richard L. King, William J. Miller, James T. Richardson and Bernard Whitney were elected as directors for a term of one year. The voting for each director was as follows:

**Proposal 2: Ratification of the Appointment of KPMG LLP as the Company's Independent Registered Public Accounting Firm**

The appointment of KPMG LLP as the Company's independent registered public accounting firm for the fiscal year ending December 31, 2016 was ratified with 6,888,469 votes in favor, 23,564 votes against and 88,998 abstentions.
