<b>Issuer:</b>	Bank of Montreal (the Bank )
<b>Title of Securities:</b>	Floating Rate Senior Notes due 2021 (the Notes ), which will be fungible with the debt securities issued on January 29, 2019 in the amount US\$417,000,000.
<b>Original Principal Amount Offered:</b>	US\$417,000,000.
<b>Reopening Amount Offered:</b>	US\$103,000,000.
<b>Aggregate Principal Amount Offered:</b>	US\$520,000,000.
<b>Maturity Date:</b>	January 22, 2021
<b>Price to Public on the Reopened Notes:</b>	100.071%, plus accrued interest from January 29, 2019 to the Reopening Settlement Date in the amount of US\$63,120.

**Expenses and Including Accrued Interest:**

- Coupon:** For each Interest Period, the then-applicable Three-Month LIBOR rate for U.S. dollars, determined on the Interest Determination Date for that Interest Period, plus 0.40% (40 basis points). In no event will the interest on the Notes be less than zero.
- Interest Payment Dates:** January 22, April 22, July 22 and October 22 of each year, beginning on April 22, 2019 (each, an Interest Payment Date ).
- Regular Record Dates:** January 7, April 7, July 7 and October 7.
- Interest Determination Dates:** The second London Business Day immediately preceding the applicable interest reset date (as provided for below).
- Interest Reset Date:** Each Interest Payment Date.
- Interest Period:** The period commencing on any Interest Payment Date to, but excluding, the next succeeding Interest Payment Date, and in the case of the last such period, from and including the Interest Payment Date immediately preceding the Maturity Date to but not including such Maturity Date.
- London Business Day:** Any day on which dealings in U.S. dollars are transacted in the London interbank market.
- Three-Month LIBOR:** For any Interest Determination Date, the offered rate for deposits in the London interbank market in U.S. dollars having an index maturity of three months, as of approximately 11:00 a.m., London time, on such Interest Determination Date. LIBOR will be determined by the offered rate appearing on the Reuters screen LIBOR01 page or any replacement page or pages on which London interbank rates of major banks for U.S. dollars are displayed (such determination to be made as set forth in the prospectus supplement accompanying the pricing supplement).

<b>Day Count:</b>	Actual/360.
<b>Day Count Convention:</b>	If any Interest Payment Date falls on a day that is not a business day for the Notes, the Bank will postpone the making of such interest payment to the next succeeding business day (and interest thereon will continue to accrue to but excluding such succeeding business day) unless the next succeeding business day is in the next succeeding calendar month, in which case such Interest Payment Date shall be the immediately preceding business day and interest shall accrue to but excluding such preceding business day. If the Maturity Date or a redemption date for the Notes would fall on a day that is not a business day, the payment of interest and principal will be made on the next succeeding business day, but no additional interest shall accrue and be paid unless the Bank fails to make payment on such next succeeding business day.
<b>Calculation Agent:</b>	BMO Capital Markets Corp. For each Interest Period, the Calculation Agent will calculate the amount of accrued interest by multiplying the principal amount of the Note by an accrued interest factor for the Interest Period. This factor will equal the sum of the interest factors calculated for each day during the Interest Period. The interest factor for each day will be expressed as a decimal and will be calculated by dividing the interest rate, also expressed as a decimal, applicable to that day by 360.
<b>Redemption Provisions:</b>	The Notes may be redeemed upon the occurrence of certain events pertaining to Canadian taxation.
<b>Canadian Bail-in Powers Acknowledgement:</b>	Yes. The Notes are subject to bail-in conversion under the Canadian bail-in regime.
<b>Reopening Trade Date:</b>	February 1, 2019.
<b>Reopening Settlement Date:</b>	February 5, 2019 (T+2).
