- (1) The number of underlying securities is based on the stock fund balance on September 1, 2005. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 1, 2005 stock fund price of \$59.6199 per share.
 - (2) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.

 - (6) The phantom stock units were accrued under the Johnson Controls Long-Term Performance Plan and are to be settled 100% in cash upon the reporting person's retirement.
