- (1) Each restricted unit represents a contingent right to receive the cash value of one share of Fluor common stock.

- (3) The restricted stock units vest in five equal annual installments beginning on May 7, 2005. Out of the 730 units originally granted, 292 have vested and 438 remain unvested.
- (4) The restricted stock units vest in five equal annual installments beginning on May 7, 2006. Out of the 550 units originally granted, 110 have vested and 440 remain unvested.
