(1) 50,000 restricted shares of common stock vested upon the occurrence of a Trigger Event, as reported previously on the 8-K filed by Aether Holdings, Inc. on June 7, 2006. At the time of vesting, the Reporting Person incurred a tax liability associated with the vesting of such shares. Under the terms of the restricted stock grant, the Board of Directors provided that the Reporting Person could satisfy his tax withholding obligation upon the vesting by surrendering a number of vested shares having a value on the date of vesting equal to the tax withholding obligation. On June 8, 2006, the Reporting Person instructed Aether Holdings, Inc. to withhold shares to satisfy the tax withholding obligation.
