(1) Each issuer deferred stock unit disposed of in exchange for a cash payment equal to the fair market value of a share of issuer common stock on the closing of the merger contemplated by a merger agreement (the "Merger Agreement") between the issuer and Freeport-McMoRan Copper & Gold Inc ("Freeport"). Pursuant to the terms of the issuer's Directors Stock Unit Plan, cash payments in respect of deferred stock units are made 30 days after the closing date.

(2) Each issuer stock unit in the Directors Deferred Compensation Plan disposed of in connection with the merger contemplated by the Merger Agreement in exchange for a Freeport stock unit representing the right to receive 0.67 shares of Freeport common stock and a cash amount of \$88.00.
