- (1) The shares were sold as follows: 22,000 shares sold by IVP Founders Fund I, L.P. ("IVP FF"). The remaining shares are held as follows: 31,746 shares by Institutional Venture Management VII, L.P. ("IVM VII"); 56,819 shares by IVP FF; 2,264,990 shares by Institutional Venture Partners VII, L.P. ("IVP VII"); 2,271 shares held by Redpoint Associates II, LLC ("RA II"); and 81,544 shares held by Redpoint Ventures II, L.P. ("RV II").
- (2) The Reporting Person is a General Partner of IVM VII and Institutional Venture Management VI, L.P. ("IVM VI"). IVM VI serves as the sole general partner of IVP FF and IVM VII serves as the sole general partner of IVP VII. The Reporting Person is also a Managing Director of Redpoint Ventures II, LLC, which serves as the sole manager and general partner of RA II and RV II, respectively. The Reporting Person shares voting and investment power over the shares held by IVP FF, IVM VII, IVP VII, RA II and RV II. The Reporting Person disclaims beneficial ownership of the shares held by IVP FF, IVM VII, IVP VII, RA II and RV II except to the extent of his proportionate pecuniary interest therein.
