- (1) The options shall vest as to 25% of the shares on each of April 6, 2008, April 6, 2009, April 6, 2010 and April 6, 2011.  
 On April 6, 2007, Mr. Glaser was granted a performance-based option to purchase 500,000 shares of common stock. The option must be earned based on the achievement of certain performance criteria for the fiscal year ending December 31, 2007. If the performance criteria were achieved at a minimum level of 90% but less than 100%, 250,000 options would be deemed outstanding as of the February 1, 2008 validation date, and the remaining 250,000 options would be forfeited. The applicable performance criteria were satisfied at a level greater than 90% but less than 100%, and therefore, 250,000 options are outstanding as of February 1, 2008 and will vest in equal increments on each of April 6, 2008, April 6, 2009, April 6, 2010 and April 6, 2011.
