The sale of shares on April 13, 2009 by the reporting person's son was matchable under Section 16(b) of the Securities Exchange Act of 1934 with the reporting person's purchase of shares on February 25, 2009 (to the extent of 100 shares purchased on that date) at prices of

(1) \$8.02 and \$8.03 per share, which were the lowest purchase prices of any purchases made by the reporting person within six months of the reported sale. The reporting person has paid \$68.80 to Sara Lee Corporation, which represents the full amount of profit realized in connection with the short-swing transaction.

(2) Includes 532,320 restricted stock units (RSUs) that may be settled only for shares of common stock. RSUs generally vest one to five years after the grant date and, upon vesting, are convertible into shares of common stock on a one-for-one basis. RSUs vest either based on the reporting person's continued employment through the vesting period, or to the extent predetermined performance targets are achieved.
