- (3) The phantom share award granted on December 22, 2006 vests in four equal annual installments on the anniversary of the grant date. The vested phantom shares are payable solely in cash within 20 business days after the vesting date. The original grant was for 7,500 phantom shares, of which 1,875 shares vested on December 22, 2007, 1,875 shares vested on December 22, 2008 and 1,875 shares vested on December 22, 2009.
