Each performance right represented a contingent right to receive one share of the issuer's common stock at vesting. The performance rights vested at a rate of 200% (plus dividends accrued on the underlying shares) based on the issuer's average return on net assets ("RONA") during a three-year performance cycle beginning on January 1, 2007 and ending on December 31, 2009 in comparison to the average RONA of a predetermined peer group over the same performance cycle.
