  - (1) DSUs. Deferred Share Units are fully vested at grant and are automatically deferred until the reporting person ceases to be a trustee, at which time the units convert into ProLogis common shares on a 1-for-1 basis. Balance in column 9 includes dividend equivalent units which are also deferred.
  - (2) Feinberg - Reporting holdings of 5,000 fully vested non-qualified stock options with an exercise price of \$20.75, expiring 5/18/2010 and 5,000 fully vested non-qualified stock options with an exercise price of \$20.80 expiring 5/17/2011. Also includes 5,676 related Dividend Equivalent Units earned on certain stock options and paid in common shares on a 1-for-1 basis upon exercise or at expiration of the underlying options.
  - (3) Reporting holdings of phantom shares. Represents trustee fees payable in common shares that the filer has elected to defer into phantom shares. Also includes phantom shares earned through dividend reinvestment related to the phantom shares. Phantom shares are payable in common shares generally upon retirement from the board. Phantom shares are convertible into common shares on a 1-to-1 basis.
