 - (2) The Stock Appreciation Rights (SARs) were issued at the closing price of the Company's stock on August 26, 2011 (\$28.76). Upon exercise, the holder will receive in Belden stock the excess of fair market value per share at the time of exercise over the exercise price, times the number of SARs being exercised.
