The Compensation Committee authorized the issuance of the underlying shares based upon the Company's achievement level against certain financial targets as determined by the Compensation Committee. The financial targets were set by the Compensation Committee on March 9, 2015. One-third of the shares vested on February 15, 2016, with the remaining two-thirds of the shares vesting in two equal annual installments beginning on February 15, 2017.
  - (2) This sale was effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on May 4, 2015.
