(2) shares granted as a restricted stock award under the Company's 2010 Equity Incentive Plan that were to vest in eight quarterly installments over two years pursuant to the Restricted Stock Award Agreement between the Reporting Person and the Company dated as of August 1, 2011 (the "2011 Award"). However, on November 1, 2012, Mr. Zhao agreed to forfeit the unvested shares under the 2011 Award, receiving a total of 25,000 shares under the 2011 Award.
