Disposed in connection with the merger of the issuer with Freeze Operations, Inc. pursuant to that certain agreement and plan of merger dated June 17, 2007, by and among the issuer, Freeze Operations Holding Corp. and Freeze Operations, Inc. (the "Merger"), in exchange for the right to receive a cash payment equal to \$15.50 per share.

In connection with the Merger, the 2007 Threshold EBITDA under the 2003 Incentive Plan (2007 Long-Term Incentive Plan) was deemed to have been achieved and the reporting person became entitled to receive 6,329 shares, which shares were canceled in the Merger in exchange for the right to receive a cash payment equal to \$15.50 per share.

- (5) became fully vested, and were canceled in connection with the Merger in exchange for a cash payment of \$7,482.00, representing the difference between the exercise price of the options and \$15.50 per share.
