 Grant of restricted share units. Each restricted share unit represents a right to receive one share of common stock. The restricted share units vest over a period of two (2) years with 50% vesting on the first anniversary of the date of the grant and the remaining 50% vesting on the second anniversary of the date of the grant.
- (2) Initial conversion/exercise price. The conversion/exercise price is subject to adjustment.
- (3) The Series A convertible preferred stock is convertible at the election of the holder at any time and has no expiration date.
