- (1) The sales reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on November 18, 2010.
- (2) The transaction was executed in multiple trades at prices ranging from \$58.18 to \$58.50. The price reported above reflects the weighted average sale price.
